While fatal accidents at theme and amusement parks are rare (less than 5 ride-related deaths per year), there are more than 30,000 theme-park-related injuries reported worldwide annually. Some of the accidents that occur at amusement parks leading to severe injuries (or even deaths) include ride malfunctions, falling or jumping off rides, guest or staff member negligence (ignoring or deliberately breaking safety rules), and freak accidents.

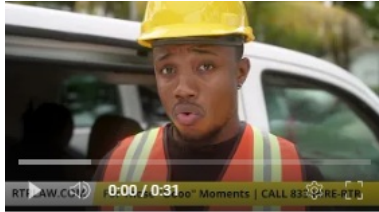
